## Child Safeguarding Statement

Patrician Academy is a post-primary school providing primary/post-primary education to pupils from First Year to Leaving Certificate Year.

- fully respect confidentiality requirements in dealing with child protection matters.

- Risk of harm to children with SEN who have particular vulnerabilities
- Risk of harm to child while a child is receiving intimate care
- Risk of harm due to inadequate Code of Behaviour
- Risk of harm in one-to-one teaching, counselling, coaching situation
- Risk of harm caused by a member of school personnel communicating with pupils in an inappropriate manner via social media, texting, digital device or other manner
- Risk of harm caused by member of school personnel accessing/circulating inappropriate material via social media, texting, digital device or other manner.




